3. 2020 What a Year

3 The future of ALLA NSW: What we did in 2020

Like many things in 2020 there was some disruption, there was some re-framing how we connect as a committee and a blurred balance between work, family, friends, ourselves and ALLA.

We sought legal advice from Prolegis (below) and have attained high level support and agreement with ALLA Ltd and from the other State Divisions to proceed.

Prolegis advice:

The distribution of ALLA NSW assets to ALLA Ltd is in accordance with relevant provisions of ALLA NSW rules on condition:

- a) Members of ALLA NSW approve the distribution of assets by special resolution
- b) It is approved by the Commissioner for Fair Trading, Department of Finance, Services and Innovation (or their delegate). This approval is contingent on the copy of the resolution and a detailed list of our assets and proposed distribution.

We would agree to a new MOU between ALLA Ltd and ALLA NSW to set out the terms of the new arrangement to replace our current MOU that will need to be terminated effective on the completion date of the restructure.

We would then apply to the Office of Fair Trading, apply to have our charity status revoked and cancel our ABN with the ATO.

4 What next

Special Resolution

We are bringing a special resolution to this AGM for current financial members to approve ALLA NSW cancellation of our registration with the Office of Fair Trading, and to distribute our assets to ALLA Ltd. This is a requirement of our cancellation of our associations status with OFT and also for the cancellation of our charity status.

MOU

The current MOU will be replaced with a new MOU on the date that our restructure is completed.

While the details are still being finalised this new MOU will be brought to an ALLA Ltd Special General Meeting to be held in February.

The new MOU will:

- Commence on the date of the effective completion of ALLA NSW restructure and will terminate the current MOU.
- Replace the words "State and Territory Divisions" with the words "State and Territory Divisions and State and Territory Chapters" to acknowledge that some States and Territories will remain Divisions and some will move to a Chapter model.
- Articulate that membership fees are paid to ALLA Ltd, and that ALLA Ltd will retain all membership fees of State Based Chapters.
- State that ALLA NSW members will be considered members of ALLA Ltd.
- Include provisions on the process for financial operations of State based chapters:
 - Chapters will call on the Treasurer of ALLA Ltd to pay reasonable expenses up to the Division disbursement amount in any financial year.
 - A mechanism for prior approval by ALLA Ltd for expenses above that amount.

Timeline:

10 December	Special Resolution passed by members of ALLA NSW regarding the distribution of assets
January	MOU draft is agreed by ALLA Ltd and other State and Territory Division presidents.
	Documents and assets information are prepared.
February	MOU is ratified by Special General Meeting of ALLA Ltd
March	Done and dusted.
