

# Australian Law Librarians' Association (Vic) ANNUAL GENERAL MEETING 2017

## **Minutes**

## **BUSINESS**

# 4. Treasurer's Report

## **ASSETS**

At the end of the financial year, ALLA Vic had assets of \$37,216.20 cash at bank. The Cheque Account had a total of \$5,389.02 and the Savings Account a total of \$31,827.18.

Interest earned on the Savings account for this period was \$212.11

**Memberships** 

Income from memberships totalled \$4,822. This is a pro-rata payment based on 151 individual memberships.

Note that disbursements from ALLA National are 50% across all membership types (i.e. \$42.50 per ordinary full time member; \$30 for part-time; \$25 for student and retired members, and \$50 for commercial members).

## Grants to conferences

Two grants totalling \$1135.50 were awarded for the ALLA conference held in Melbourne in August 2016.

Catering and Refreshments – workshops, social events

Several social events were held during the 2016-17 financial year, including the Mid-Year function, End of Year function and Opening of the Legal Year function. Refreshments and catering were purchased for these events and for workshops and CPD sessions held throughout the year.
