We also hope that Anastasia's and Alice's presentation will encourage other ALLA members to contribute some of their time and expertise in developing modules for other Australian jurisdictions. Introducing librarians new to law librarianship to legal research skills and strategies has always been an important element of ALLA's commitment to continuing professional development. We are grateful to Anastasia and Alice's commitment to fostering this professional development opportunity for law librarians.

Vendor Relations Update

This year Monika Zygmuntowicz continued vendor discussions around ebook offerings, which were informed by responses from her 2021 ALLA ebooks & Legal Publisher survey. The survey results and a copy of the presentation from the 2021 ALLA Conference are available on the new ALLA website.

Monika is holding a live forum with legal publishers this year, based on questions and issues identified through the ALLA survey and submitted by members.

Another area of focus has been around the rollout of New Westlaw. Monika has been working closely with Thomson Reuters to enhance the user experience and to suggest and prioritise updates to the platform.

She is also working with vendors to formalise the way ALLA members can contribute to the development of subscription resources and beta testing. Watch the Vendor News and Offers space.

Website Redevelopment

ALLA commissioned the redevelopment of the ALLA website as the old web platform was no longer fit for purpose in the current environment to provide the UX/UI experience required for ALLA members. This resulted in the gradual transition of the ALLA website from the old platform to the new platform, which utilises Wix. The selection of Wix to build the website was based on Wix's wide range of capabilities to provide bespoke spaces such as the members' portal, an internal event and CPD management system, as well as better optimisation for search engines. This was also an opportunity to have a new URL for the website, which was interoperable with the existing IT systems and processes.

The migration process was met with obstacles such as managing the large file sets that were not properly filed and classified on the website and the past CPD recordings, which were hosted on numerous platforms without any centralised coordination. Retrieval and consolidation of the CPD materials and ALLA files was a significant proportion of the project and was completed in the early stages of the migration process.

The ALLA website redevelopment also opened opportunities to update existing workflows and processes that were outdated. These included the email system, mailman mailing lists and the file management system, these are currently in the deployment and testing stages. All these systems will be migrated to the Google Suite due to better capabilities and functions as the IT solutions platform of choice. ALLA's charitable status allowed us to take full advantage of the Google Suite for not for profits (Google for Nonprofits) which provided no operational costs to ALLA.

While the website has been completed, other areas of development include the new email system and archival processes and policies of the old email platform. In addition, with the new systems in place, there are opportunities to utilise other technologies which ALLA has not previously been able to, such as an internalised video management system, integrated forms and operational processes with the ALLA memberships databases as well as better information and cybersecurity provisions with the new platforms.

The website was made possible with Tin Nguyen, the ALLA National Web Coordinator now known as the ALLA IT Project Manager as the lead, and supported by Emma Joneshart, ALLA National Board Director.
